### Southridge First School - Governing Body's Annual Statement 2016 -17

The Issues faced and addressed by the Governing Body over the last year were:

- Enhancement of school building – new doors in Year 1, space created for group room and meeting room
- Computer hardware needed upgrading
- Embedding Curriculum and Assessment Procedures
- Staffing changes – induction of new staff – NQT in Yr 1 / DHT in Yr 1 and appointment of Assistant Head
- Safeguarding Policies all updated in line with Keeping Children Safe in Education
- Induction and Involvement of new Governors
- Monitoring Sports Premium Funding
- Ensuring all Health and Safety standards are met

The impact of the Governing Body on the school was:

- Headteacher appointment ensured standards have been maintained in all key phases - End of Reception GLD is 83%, Year 1 Phonics -93%, Year 2 SAT's standards improved, Year 4 exit data demonstrates sustained progress
- The Headteacher is supported by a strong Leadership Team
- The school is on a stronger financial footing – Finance Committee has cleared deficit budget and has been able to make improvements to the school building and playground
- Assessment System in place for core subjects.
- All classrooms and the hall have new Clevertouch interactive screens installed (supported by PTA funding)
- 2 new teaching staff – NQT and DHT bring new skills and qualities to the school
- Full awareness of safeguarding
- A working party has developed a 'Governing Body Development Plan' with clear lines of responsibility and accountability
- The school has achieved the Gold Award in School Games
- The school has been awarded Healthy Schools Accreditation again
- The school was awarded a 'Gold' certificate in a Local Authority Health and Safety Inspection
